**OPEN LETTER TO PRESIDENT BARROSO ON
THEMATIC STRATEGY ON AIR QUALITY
30th JUNE 2005**

Dear President Barroso,

The European Commission is under a legislative obligation under the 6th Environmental Action Programme to come forward with a Thematic Strategy on air pollution in 2005. DG Environment committed in Parliament to publish this strategy in July with accompanying proposals for revised and new air quality legislation. We the undersigned, in the interest of people's health and well-being, ask you not to give in to pressures from governments or industry to delay.

According to the European Commission's own Impact Assessment¹ every year 369,980 people die prematurely because of air pollution. To put this in perspective this represents losing nearly the population of Malta every year. Premature death, health care and medication due to air pollution amounts to between 3% to 10% of the EU GDP but this figure does not include the pain and suffering of individuals and their families.

European citizens need strict air quality standards that reduce this burden on our society, especially the impact on vulnerable groups – infants, children, the elderly and those suffering from asthma and other respiratory diseases. In children, outdoor air pollution is associated with acute lower respiratory tract infections, asthma, low birth weight, and impaired lung function. Evidence is now overwhelming that small particles (PM10 and PM2.5) are for a large part responsible for these adverse health impacts and deaths.

The European Commission, together with Environment and Health Ministers throughout Europe signed in Budapest in 2004 the WHO Children's Environment and Health Action Plan for Europe in which you committed '*to prevent and reduce respiratory disease due to outdoor and indoor air pollution, thereby contributing to a reduction in the frequency of asthmatic attacks, in order to*


